

## **Security Management Stage 3**

Muscat, Sultanate of Oman

## **Background**

This programme is designed to enhance Security Managers' ability to formulate security policy and manage security programmes at a regional and/or strategic level. Great emphasis is placed on broadening delegates' contribution to their organisation's security risk management strategy.

It is assumed participants have already attended Security Management Stage 2 (or equivalent).



This course is Skills for Security Accredited and forms the second part of the pathway towards the University of South Wales MSc in International Security and Risk Management (Masters Degree)

This course encompasses a security management project, which is designed to provide a realistic context in which delegates undertake a comprehensive analysis of the existing and future strategic challenges facing a notional company. The delegates are required to make recommendations on how the company can mitigate the risks whilst addressing the needs of company stakeholders in a balanced manner and simultaneously ensuring that corporate interests remain paramount.

# MSc with the University of South Wales







Clients who complete the Security Management Stages 1,2 and 3 can then go on to complete a Masters degree on a distance learning platform through our sister company, Perpetuity Training Academy, in collaboration with the University of South Wales (USW).

The MSc International Security and Risk Management develops and enhances critical theoretical knowledge, security management skills and understanding in an area which presents significant demand for professionalization worldwide. This Masters programme is delivered through online distance learning. Gain valuable interaction with others on the course through a specially designed online learning platform, which includes virtual forums and discussion groups.

Supported by course tutors from both Perpetuity Training and USW, students will be enrolled directly with USW and will have full online access to the University library.

Each completed ARC Training Security Management Stage gains university credits towards the full MSC. Upon completion of all three stages, delegates can apply for a total of 80 credits from the 180 credits required for the full MSc. If awarded, learners will be exempt from the three modules and will receive a discount from the course fee.
